Payment Terms and Conditions:

A booking fee of £50.00 per person is payable at the time of booking, this fee is not refundable if students cancel the booking within four weeks of the commencement of the activity.

The remaining balance is to be paid no later than four weeks before the start date of the activity. Payment can be made by either Cheque, Credit/Debit Card. Cheques should be made payable to: 'Southwest Powerboating'. Payment by cash can only be accepted at our office please do not send cash in the post. Due to bank charges to us, a 2% charge will apply to all credit card transactions.

Medical Declaration:

You are required to make a declaration that you are fit and able to participate in the activity and inform Southwest Powerboating of any medical condition or illness that may affect your participation. This information will only be used by Southwest Powerboating to ensure the correct level of care is provided if required. You are required to inform Southwest Powerboating if you are a Non swimmer.

Next Of kin Details:

Clothing and Equipment:

Southwest Powerboating will provide all the relevant safety equipment applicable to your chosen activity, a limited amount of Foul Weather Clothing is available however we strongly recommend you provide your own to ensure a comfortable fit. Footwear is not provided; we recommend none slip soled footwear applicable to the time of year.

Own Boat Tuition:

You are required to have Third Party Liability Insurance to cover your craft during the period of your training with us. Your vessel must also be equipped with the mandatory safety equipment for the activity. RYA ratios are to be adhered any Publications and certification are not included. Southwest Powerboating does not provide food, beverages or fuel.

Publications And Certificates:

Southwest Powerboating will provide publications and certificates applicable to your chosen course as listed on Course Prices these where stated are included in the course fee.

Personal Liability:

Southwest Powerboating is under no liability in respect of any personal injury however caused during your participation on a course. It is recommended that you arrange to have personal accident insurance cover.
